The opioid epidemic has increasingly affected older adults, a group that is particularly vulnerable to the adverse effects associated with opioid use. A common but little understood setting for new opioid prescriptions is following surgery, a time when older adults are particularly vulnerable to adverse effects of opioids given the fragmented nature of post-surgical care and patients' clinical fragility post-operatively. The proposed research will improve our understanding of the effects of opioid prescribing following surgery on long-term opioid use and opioid-related adverse outcomes in older adults, with a specific focus on using quasi-experimental research methods to demonstrate how individual surgeons and pain management techniques such as regional anesthesia may influence chronic prescription opioid use and opioid-related adverse outcomes following surgery.

Opioid prescribing rates have quadrupled in the United States over the past 25 years, with large effects on the older Medicare population, among whom hospitalization rates for opioid overdoses have grown over five-fold since 1993. An underappreciated potential avenue through which new opioid use begins among older Americans is after hospitalization for non-surgical, general medical conditions, which comprise nearly two- thirds of all hospitalizations in the US. The proposed grant will provide national estimates of the frequency of opioid prescribing at hospital discharge for Medicare beneficiaries hospitalized with general medical conditions, study the relationship of prescribing with adverse patient outcomes and long-term opioid use, and improve our understanding of the role of specific providers - both hospitals and physicians - in driving opioid prescribing at the time of hospital discharge.

Inter-hospital transfer of patients with critical illnesses like acute respiratory failure (ARF)—by ground or by air—is a common and costly practice in the U.S. critical care system despite a limited evidence base for its efficacy in improving outcomes and unknown cost-effectiveness. The proposed study will use commercial insurance and Medicare claims data to characterize national use patterns for inter-hospital transfer of the broad population of critically ill adult patients; estimate the effect on mortality of air compared to ground transfer of patients with ARF using a novel instrumental variables approach that takes advantage of random weather conditions; and perform a rigorous cost-effectiveness analysis of the use of air compared to ground inter-hospital transfer of patients with ARF. The results of this research will provide physicians, health systems, insurers, and governments with actionable evidence to inform decisions, resource allocation, and policy surrounding inter-hospital transfer within the U.S. critical care system.
